GVTC ANNOUNCES \$4.8 MILLION CAPITAL CREDIT DISTRIBUTION TO MEMBERS

At this year's annual meeting on Wednesday, June 28, 2006, at the New Braunfels Civic Center, GVTC will distribute approximately \$4.8 million dollars in capital credits to its membership.

"The GVTC Board of Directors overwhelmingly approved this year's allotment," says Ritchie Sorrells, President and CEO for GVTC. "I am proud to announce that over the past 31 years, the total capital credit distribution given back to our membership now amounts to \$62,600,000. This clearly sets GVTC apart from its competitors."

NOTE: Capital Credit checks will not be available to members at the annual meeting on accounts with a past due balance as of June 1, 2006. The credit will be applied towards any unpaid balance.

through 2004 may collect capital credit checks only from 5:00 PM to 7:30 PM. To collect a check during this time, members are required to have working GVTC telephone service along with a copy of their Annual Meeting Notice. Capital Credit checks may only be released to the person whose name appears on the membership account.

Due to the size of the estimated distribution of over 47,000 checks, they will not be available at any of the GVTC office locations. #79037 Capital credit checks for memberships without active service will be mailed after the first week in July.

A full slate of events, hosted by Charles J. Knibbe, Chairman of the Board GVTC, is scheduled for this year's Annual Meeting. Highlights of the evening will include a review of the many accomplishments achieved at the Cooperative during 2005.
